The UCSB Graduate Student Association states unequivocally our full support for our fellow graduate students at UC Santa Cruz in their demand for a cost of living adjustment (COLA), including their engagement in a Wildcat Strike. California's housing crisis has resulted in horrific inequality across the state, especially in areas such as Santa Cruz. Here in Santa Barbara, the average cost of a one bedroom apartment hovers around \$2,000, which is roughly what a TA makes in a month.

The vast majority of graduate students spend more than half of their paychecks on housing, with many going to extreme lengths to make ends meet. This includes but is not limited to: living in their cars (if they can afford one), borrowing money from friends and family, and sometimes even relying on advisors for financial help in emergency situations. The idea of stretching the same salary in an area with even higher rents is incomprehensible to most of us. Graduate students — in Santa Barbara, Santa Cruz, across California, and across the country — deserve better.

Santa Cruz grads' decision to withhold grades is a brave and an ingenious use of our power as graduate students. The UC only works because we do, and our compensation should both reflect the value of our labor and account for the high cost of living in California. We stand in solidarity with our fellow graduate student workers at UC Santa Cruz. We demand that UC Office of the President and UC Santa Cruz administrators issue a written guarantee that there will be no retaliation against all organizers, students, faculty, workers, and staff involved in the strike. COLA now!
