Vice President of Academic Affairs // Alex LeBrun

- Time to Degree and Time to Candidacy Extension
 - All Master's and PhD Students, including international, up to 1 year
 - Things not covered: funding, NRST (yet), 18-quarter TA cap, extension of FSH housing (see <u>FAO</u>)
- S/U Grading
- Researching in the time of COVID-19 (see link)
 - 6 phases of re-opening (currently in 2, ramping up in June)
 - Currently only "critical" research projects
 - Max 25% occupancy goal

- Contact tracing, social distancing, and increased cleaning
- Library for grad student research is being treated as a lab

Vice President of Student Affairs // Maya Zaynetdinova

- UC SHIP Emergency Medical fund (\$2M) proposal
 - SB \$115,200 based on enrollment
 - Vote on May 12th
- Logisticare transportation (pilot program) for non-medical transportation in discussion
- There isn't reliable data to accurately model the financial effects of COVID 19 on health plans
- Sent a list of Basic Needs resources to all grad students
 - Housing:
 - San Clemente was able to accomodate all international students
 - an updated list of housing resources was sent out to grad students
 - Margaret T. Getman and William J. Villa award review in progress

Vice President of Budget, Finances, and Committees // Luke Rosedahl

- 88 Applicants so far for the COVID19 Relief Fund
 - ~70% Have or will receive assistance
 - 30 through the Financial Crisis Response Team
 - 31 through the COVID19 Relief Fund
 - 2 through GSA Egrant
 - 17% Pending more Information
 - only 11% we couldn't help
 - Due to savings, their situation not being caused by COVID19, or not being a grad student
 - Have awarded ~\$22,000 of \$40,000
 - If you have a COVID19 related expenses not covered by other programs, Grad Div has CARES act money to help you. Check your email for the link
