- Clarification on the Rules and Procedures:

- The GSA has limited funding available for supporting graduate student organizations' events and conferences
- Awards are available for up to \$300 per organization per quarter and may only be requested twice per academic year (for a total of \$600)
- In the November 1st General Assembly, GA representatives had voted to award \$600 to both WAIL and Healing Communities by mistake
 - A motion was approved to overturn that decision and award only \$300 per organization
 - Both organizations will be allowed to return to ask for co-sponsorship in Winter or Spring

Finance Update

- Resignation of VPFA, Gabrielle Salo on November 7th 2022
 - Both VPCE Annjulie Vester and External Co-President Eugene Riordan Jr are filling this position in the interim
 - Per Bylaws and Consitituion, special elections must be held at the next scheduled General Assembly (29th of November GA)
- What's important to know
 - The GSA Budget is in good standing and accounted for
 - Many grants have not been processed in the past months we would like to sincerely apologize for the delay in communication and processing

- The current system through which GSA processes its finances does not support the volume of transactions the organization produces
- Both Annjulie and Eugene have been working with GSA Advisor Carlos Nash to set up a new financial transaction system and to process outstanding grants (+ 40 travel grants, 17 childcare grants, 1 emergency grant)
- Special Elections
 - Due to the current state of the GSA financial system a new VPFA would have tied hands
 - The Board recommended the following actions:
 - (1) postponement of the special elections for VPFA until January 17th
 - (2) special elections for the position of adhoc officer, specifically Melanie Adams, former VPFA (2020-2022) to support processing of outstanding grants/reimbursements
 - Explanation
 - Referring to (1): a newly elected VPFA would lack a predecessor to transfer institutional knowledge and teach them the financial processes that are yet to be generated
 - Referring to (2): The Board currently has no experienced officer with the institutional knowledge to set up a new financial system or to use the old financial system to process outstanding grants - Melanie Adams has offered to help the Board temporarily (3 months or length of adhoc appointment) in this process
 - Votes
 - MOTION TO POSTPONE VPFA SPECIAL ELECTIONS: unanimously approved by present GA representatives (26 Yes, 0 No)
 - MOTION TO ELECT MELANIE ADAMS AS ADHOC OFFICER: unanimously approved by present GA representatives (26 Yes, 0 No)

- 4. Debate: The members debate the motion.
- 5. Vote: The chairperson restates the motion, and then first asks for affirmative votes, and then negative votes. "All in favor? Opposed? Abstaining?"
- 6. Announce the vote: The chairperson announces the result of the vote and any instructions.

Clarification on Co-Sponsorships

The GSA has limited funding available to support organizations' events and conferences when serve graduate students. Awards are available for up to \$300 per student organization per quarter, with a maximum of \$600 awarded per academic year per graduate student organization. (https://gsa.ucsb.edu/funding/event-co-sponsorship) - there is no language in either Constitution/Bylaws

In our November GA, WAIL and Healing Communities asked for \$600 each, and there was some concern among reps about whether we could or should confirm \$600 for one quarter.

<u>Executive Board Recommendation</u>: Motion to confirm \$300 for both Healing Communities and WAIL for this quarter and to ask them to apply again in Winter/Spring.

Finance Update

- Gabrielle resigned Sunday, 7 November 2022
- Annjulie and Eugene have taken over all VPFA duties, including committee appointments, grant decisions, reimbursements, etc.
- We want to apologize for how long this has taken us to reconcile, but we believe we have a much clearer picture of our current financial situation and pathways to payments
- We are on path to get outstanding payments to people by the end of this quarter, and are exploring options to streamline getting money to graduate students and doing what we can to move away from reimbursements only as how we can administer grants and things
 - travel grants (40+), childcare (9), emergency (~6)
- As far as we can tell, we're in a good position financially, we're just untangling a mess of *how* to get people money

Special Elections: VPFA

The VP of Budget, Finance, and Committees is the chief financial officer of the GSA. The VP prepares the annual budget, presents monthly financial reports to the GSA Assembly, keeps financial records, and processes financial transactions for grants, reimbursements, and co-sponsorships. Given the position's complexity, the VP will be supported by financial liaisons, as well as the Executive Board.

We have had several people interested in the position.

In order to better guarantee the next VPFA success in their role, and to ensure that the remaining financials of Fall Quarter get settled in a timely matter, <u>your GSA Executive Board recommends</u> <u>a motion to table the Special Election until our January GA</u> <u>Meeting.</u>

In order to meet the current gap, <u>your GSA Executive Board</u> <u>recommends a motion to appoint an Ad Hoc Officer for the rest</u> <u>of Fall Quarter and parts of the Winter.</u> (clarification on the next slide)

Special Elections: Ad hoc Officer

a. The GSA Assembly, by a two-thirds (66%) vote, may establish ad hoc Officer positions.

i. The term of office for an ad hoc Officer position shall not exceed one (1) academic quarter. The GSA Assembly, by a simple majority (50% plus 1) vote, may appoint a GSA member to fill an ad hoc Officer position.

(Article III, Section D, Constitution of the UCSB Graduate Student Association)

Melanie Adams served as the Vice President of Financial Affairs for two terms, 2020-2022.

The Executive Board has reached out to ask her about her availability to help right our financial situation and get our next officer set up for success. If approved by the General Assembly, she could start this week. The budget for this position will come out of the leftover budget from the VPFA this quarter and will work alongside the specially elected VPFA starting in January.

Recap: Options for VPFA Position

Per our bylaws, we need to have an election for the vacant VPFA position. These decisions are up to the General Assembly and you all get to decide how we as the Executive Board move forward. These are two options that we perceive, but are open to more.

Option 1: We have our regularly scheduled special election for the VPFA tonight

Option 2 (what the Executive Board recommends):

- Motion to table special election until January GA
- If successful, motion to create an Ad Hoc Officer position.
- If successful, motion to appoint Melanie Adams to the Ad Hoc
 Officer position
