- Graduate students who work as TAs, GSRs or are on full fellowships receive fee remission which covers campus-based fees like the ones discussed below
 - students who fund themselves or pay their own tuition do not have fee remission and pay out of pocket
- the GSA General Assembly votes to put fees on the general graduate student ballot in the Spring
 - votes must be approved by 66% of GA representatives present

AS Coastal Fund

- Lock-In Fee Proposal
- Student run organization on campus focused on protecting the coastal region around school
- requests \$3 per student increase (\$6) \rightarrow fees would be covered under free remission for TAs and GSRs

- Rec Center Fee

- New fee proposal
- Lock-in Fee is running out this year as the Rec Cen has paid off its 30-year loan
 - Original finance plan did not include projection for maintenance and upkeep of facilities; thus the Rec Cen risks running into financial trouble after the academic year concludes
- Current fee: 24.68 per student
- Proposed fee: \$41.60 per graduate student per quarter and \$27.74 per graduate student per summer
- Beginning Fall 2023; fee reaffirmation every 4 years and inflation adjustment every 5 years
- VOTE

Yes: 61.3%No: 35.5%Abstain: 3.2%

Result: NOT APPROVED

- Emergency Grant Fee

- Proposed language would double the mandatory fee (\$4.08 → \$8.16 per quarter, Summer excluded) in order to provide ~16 additional grants to students experiencing temporary and acute financial hardship

Yes: 90.3%No: 6.5%Abstain: 3.2%Result: APPROVED

- Food Bank Fee
 - Graduate Student currently contribute less than \$1 dollar to every ~\$5 undergraduates pay for the AS Food Bank
 - Proposal: Increase fee to match undergraduate contribution:
 - \$CURRENT FEE \$0.85 → INCREASED FEE \$4.96
 - VOTE:

- Internal Co-President (Becky Martin)
 - SEAL: GSA is working on removing removing requirements for graduate led registered student organizations
 - alternatively, GSA believes graduate led RSOs should receive specific training that is tailored to the graduate experience rather than the undergraduate experience
- VP Communications & Events (Anniulie Vester)
 - March 10th Event
 - Dinner and Games Night at the GSA Lounge
 - Capacity: 130 students
 - Sign-up coming soon
- VP Graduate Student Affairs (Sara Tyberg)
 - UCSHIP Insurance renewal process started
 - Increase to fertility testing benefits; 2) expansion of nutrition/dietician services for members with ulcerative colitis, Crohn's, celiac disease, and diverticulitis; 3) dental benefit increase; 4) free prescriptions for male condoms; and 5) updated language around gender-affirming care
 - Anticipated ~12% increase in premiums for '23-'24 plan year (this is if none of the above proposals are passed)
 - Will know more if it seems like the proposed changes will pass next week after EOB student caucus meeting
 - Discussion at SHAC about hiring a security officer for Student Health because of safety concerns
 - Continuing Graduate Housing application will open March 1st
- VP External Affairs (Anne Berry)
 - UCGPC is discussing the problem of increase in availability of online undergraduate courses throughout the UC system
 - UCGPC Advocacy Day in Washington DC (end of March)

Discussion Items (will NOT be voted on in March meeting)

- VPFA position
 - proposal to amend Constitution/Bylaws to move VPFA Committee duties under VPCE duties
 - Explanation: The VPCE is already in charge of recruiting General Assembly representatives a pool from which Committee representatives are drawn. The VPCE is the primary communicator of the organization and collects contact information of General Assembly representatives. Hence, the VPCE is naturally in the position to coordinate the selection of Committee representatives with much more ease than the VPFA
 - proposal to improve the durability of GSA Finances through either 1) creation of a second VPFA officer position or 2) addition of VPFA oversight to the duties of either Co-President or 3) creation of a GSA position similar to the Chief of Staff who acts as a liaison

Rec Cen By The Numbers

- Average 18,613 visits weekly (high of 24,381)
- Average 2,659 visits daily (high of 4,708)
- ~60% of undergraduates utilize the facility
- ~50% of graduate students utilize the facility
- ~390 faculty & staff members
- Employ ~280 Rec Cen Student Employees
 - ~700 total across the whole department

Rec Cen I Lock In Fee

- Originally passed in 1990
 - Build, operate, and maintain the Rec Cen
- Grand Opening in 1995
- Bond (mortgage) will be paid off this year and the original ballot language states that the Lock In Fee will end at that time.
- Original architects of the Lock In Fee didn't factor in ongoing operating expenses and maintenance.
- Rec Cen receives NO financial investment/ support from Campus, State, or Tuition





Student Lock In Fee Comparison







Do you wish to increase the current Graduate Student Emergency Relief Grant Fund mandatory fee of \$4.08 by \$4.08 (\$2.89 goes to the fund, \$1.02 is for return-to-aid, and \$0.17 is for administrative tax) for a total of \$8.16 per graduate student, per quarter (excluding summer) to increase the number of available grants for registered graduate students experiencing temporary and acute financial hardship? If passed, the increase would continue to be collected until subject to joint reaffirmation (original Graduate Student Emergency Relief Grant Fund plus this increase) in spring 2025.

The fee increase would allow the GSA to meet the current demand for this grant and award approximately 16 more allocations for graduate students experiencing temporary and acute financial hardship.

Summary:

 This proposed language would double the mandatory fee (\$4.08 → \$8.16 per quarter, Summer excluded) in order to provide ~16 additional grants to students experiencing temporary and acute financial hardship.

Food Bank Contribution

- At present, undergraduate students contribute \$4.96/qtr and during summer towards the Food Bank
- Graduate students, by comparison, contribute \$0.85/qtr and nothing in the summer towards the Food Bank
- In the year of 2021-22 school year, 21.8% of undergraduates and 21.2% of graduate students used the food bank

A combined experimental and computational approach to characterizing chemical patterning effects on interfacial water



Abstract: Chemical patterning shows potential for tuning the structure and dynamics of hydration waters. In this talk, we bring together molecular dynamics simulations and state of the art magnetic resonance techniques to investigate the effects of chemical patterning and surface architecture on water behavior. Understanding how to use surface composition to control water behavior will enable design of made-to-order materials, such as marine antifouling coatings and water filtration membranes. Here, we consider porous membranes from several nanoscale perspectives. First, we use polypeptoids to understand the hydration of small-molecules used to modify membrane surface chemistry. Next, block copolymer micelles are used to probe water behavior within the soft wall of a membrane pore. Finally, patterned nanopores shed light on the effects of surface patterning on water transport in membrane pores.

- UCSHIP Insurance renewal process started
 - Several proposed changes, including 1) increase to fertility testing benefits; 2) expansion of nutrition/dietician services for members with ulcerative colitis, Crohn's, celiac disease, and diverticulitis; 3) dental benefit increase; 4) free prescriptions for male condoms; and 5) updated language around gender-affirming care
 - Anticipated ~12% increase in premiums for '23-'24 plan year (this is if none of the above proposals are passed)

Discussion Item 1: VPFA position

Current position: Vice President of Budget, Finance and Committees Change 1 (Bylaws (p. 16) and Constitution):

- Move Committee work under VPCE position → VPCE already collects information for GA representatives (which often fill Committee positions)
- Articles
 - The VPFA shall maintain current information regarding UCSB committees and similar bodies and shall post such information to the GSA website at least quarterly in coordination with the VPCE.
 - r. The VPFA shall maintain a current list of administrative contacts, mission statements, and other information relevant to committees for which the GSA appoints committee representatives.
 - s. The VPFA shall maintain a list of all GSA Committee Representatives and their contact information.
 - t. The VPFA shall publicize vacant committee positions and recruit a diverse group of graduate students to serve on-campus committees.
 - u. The VPFA shall handle correspondence regarding the application process for GSA Committee Representative positions.
 - v. The VPFA shall request, receive, and record all Committee Representative reports
 about their respective committees and post an executive summary of each quarter's
 reports to the GSA website in coordination with the VPCE.
- VPFA is still responsible for collection Committee representative hours and paying the stipends connected to them

Discussion Item 1: VPFA position (cont.)

Change 2: Preventing a loss of knowledge and/or control over finance

 Discussion: VPFA is currently the only designated person with access/control/knowledge of how GSA finances work

Option 1:

- Make one other Board member 'Vice of the Vice-President'
- responsible for learning GSA Finance
- access to VPFA Gmail and Drive at all times

Option 2:

- Creating a new position and electing a second VPFA who works in tandem with the existing one
- to be elected in alternating years

Discussion Item 2: GA rep stipends

Current rule:

GSA Stipends to Departmental GSA Representatives

- a. The GSA Assembly shall provide a stipend in the fall, winter, and spring quarters to each departmental GSA representative that attends the monthly General Assembly meetings.
- b. The amount of the stipend shall be \$22.50 per meeting.
- c. Stipends shall be paid directly to the departmental GSA representative within 30 calendar days of the last day of the quarter.
- d. To receive their stipend, departmental GSA representatives must complete a committee pay form listing their General Assembly attendance.
- e. Departmental GSA representatives must have signed in when attending the General Assembly to confirm attendance.
