Discussion Items (to be voted on during February General Assembly)

- AS Coastal Fund
 - Lock-In Fee Proposal
 - Student run organization on campus focused on protecting the coastal region around school
 - requests \$3 per student increase (\$6) \rightarrow fees would be covered under free remission for TAs and GSRs
- Rec Center Fee
 - New fee proposal
 - Lock-in Fee is running out this year as the Rec Cen has paid off its 30-year loan
 - Original finance plan did not include projection for maintenance and upkeep of facilities; thus the Rec Cen risks running into financial trouble after the academic year concludes
 - Current fee: 24.68 per student
 - Proposed fee: ~\$80 per graduate student and ~\$100 for undergraduate students
- Emergency Grant Fee
 - Proposed language would double the mandatory fee (\$4.08 → \$8.16 per quarter, Summer excluded) in order to provide ~16 additional grants to students experiencing temporary and acute financial hardship
- Food Bank Fee
 - Graduate Student currently contribute less than \$1 dollar to every ~\$5 undergraduates pay for the AS Food Bank
 - Proposal: Increase fee to match undergraduate contribution

March 1 | Housing Application Opens

Applying for housing is not a guarantee that you will receive a contract. Please check your U-Mail account directly and frequently so that you don't miss any important messages from UCSB. It is not reliable to forward your U-Mail to an alternate email (gmail, yahoo, hotmail, etc.) If you don't receive a confirmation email from us within a few minutes of submitting your application, check your spam folder.



March 13 | Housing Application Closes

The housing application closes on March 13 for on-time consideration. All students applying after March 13 will be added to the late applicant list for consideration after our new student application processes are concluded.



Late March | Contracts Offered

Contract offers will be determined by a lottery process. Students who receive a contract may exercise the option to choose preferred roommates. We anticipate that available space in our housing communities will be limited. Students not awarded an offer initially, but who also applied by March 13, may remain on a priority list for future spaces. We recommend students without contracts explore other possibilities and attend our **educational programs** regarding community housing options.



July 1 | Roommate Process Deadline

Students who have a 2023-24 contract can create a roommate group with other contract holders in the university apartments by using the optional roommate process. This is optional and those who do not complete the process by July 1 will be matched based upon the answers to their roommate preference questions.

July 17 | Cancellation Deadline for \$100

There is a \$100 cancellation fee from the time of signing the contract until July 17. After July 17 there is a \$350 cancellation fee until August 31.

August 31 | Cancellation Deadline for \$350

The deadline to cancel your housing contract for a \$350 cancellation fee is August 31. If you've already moved in or it's after September 1, you may cancel by submitting a 30-day notice of termination and will be responsible for rent through the end of that 30 days.



July 28 | Room Assignments

Assignment letters will be sent along with instructions for signing up for a time to arrive on campus.

Housing Priority

- We typically house 40% of our graduate student population between San Clemente and Family Student Housing
- ALL students must apply on time to be considered for a continuing student contract for San Clemente
- No housing guarantees
- Please check your UCSB email DAILY including your spam folders so you do not miss any updates



How Are Contracts Assigned

Students with completed applications ON TIME will be considered for a contract

- Continuing students will apply for a continuing housing application
- Once they do this they will be considered for a contract
- We anticipate that we will be limited to about **375 spaces** for continuing graduate students.
- Last year we had a weighted lottery for spaces because we had more applicants than space available for continuing students
- Students WILL be notified if they are offered a contract by late March
- If you do not receive a contract offer it is important that you seek community housing as we cannot guarantee an offer at a later date

NOTE: Students MUST check their UCSB email daily for updates



Family Student Housing

- Family Student Housing is available to registered, full-time student with families
- Contracts are allocated through a waitlist process
- Average wait time:
 - 6 to 12 months families without children
 - 3 to 6 months families with children
- Priority is given to families with children
- Prospective students do not need to be enrolled at UCSB at the time of application to the waitlist



- Not furnished
- Partial utilities included trash/recycled and sometimes water
 - Gas, Electricity, Wifi and Cable (average \$100 a month per apartment)
 - Start up costs for utilities
- Mostly shared room
- Prices will vary depending on single, double or triple space
 - Most will be shared spaces



Goleta/Santa Barbara

- 12 month lease terms
- Joint and several lease
- Security deposit required (can be equal to 2 times the rent)
- No cosigners so if you don't meet the income requirements we can usually work with the management company to see if you can pay an increased security deposit
- First months rent and sometimes last months rent due upon lease signing (will vary from management company to management company)
- Not Furnished
- Partial utilities included trash/recycled and sometimes water
 - Gas, Electricity, Wifi and Cable
 - average \$100 a month per apartment
 - Start up costs for setting up utilities
- Singles or doubles depending on the price point you want to pay and the amount of people you want to live with





Projects We Fund

- Field studies and **research projects** run by graduate and undergraduate students
- Increased **accessibility for historically marginalized communities** through programs such as The Sea League, a new Black-led organization in Santa Barbara that seeks to engage youth and communities of color in ocean sports, and programs that provide wheelchair users with all-terrain devices to explore our local beaches and trails


 Undergraduates pay twice as much per student as graduate students, but graduate students request funds much more frequently than undergraduates



Our Problem

Increasing Demand & Price Tag

- Number of applications for funding has substantially increased
- Demand **immediately** bounced back after COVID
- Average amount requested per application has steadily increased, especially with wage increases
- Operating on a budget that is outdated and has only increased due to growth in the student population






Coastal Fund is Unique

- Help new academics develop their first projects rather than further concentrating funding amongst already prestigious researchers
- Student-centered emphasis on **equitable** wages for labor and quality of experience

- Average 18,613 visits weekly (high of 24,381)
- Average 2,659 visits daily (high of 4,708)
- ~60% of undergraduates utilize the facility
- ~50% of graduate students utilize the facility
- ~390 faculty & staff members
- Employ ~280 Rec Cen Student Employees
 - ~700 total across the whole department

Rec Cen I Lock In Fee

- Originally passed in 1990
 Build, operate, and maintain the Rec Cen
- Grand Opening in 1995
- Bond (mortgage) will be paid off this year and the original ballot language states that the Lock In Fee will end at that time.
- Original architects of the Lock In Fee didn't factor in ongoing **operating expenses** and **maintenance**.
- Rec Cen receives **NO financial investment**/ support from Campus, State, or Tuition

Rec Cen I Lock In Fee & Inflation

- The fee has **not increased** since it was passed
- Inflation has gone up 128.57% since 1990
- You need \$228.57 to buy today what cost \$100 in 1990




